

BURGLARY AND ROBBERY EXTENSION ENDORSEMENT - E25

In consideration of the premium charged, IV. Perils Insured of the Fire and Extended Coverage Rider - F2 is extended to include the following perils:

10. Burglary: This peril means theft following the felonious entry into or exit from the premises by actual force and violence of which force and violence there shall be visible marks upon the premises at the place of such entry or exit.

This peril does not include loss or damage:

- (a) occurring while the building is under construction or vacant irrespective of any permission for construction or vacancy elsewhere in this policy;
 - (b) caused directly or indirectly by any employee, tenant, tenant's employee, tenant's guest or a member of the tenant's household. "Tenant" includes any person who has the Insured's permission to occupy the dwelling or any part of it.
11. Robbery: This peril means theft accompanied by violence or threats of violence to any person used to extort the property stolen or to prevent or overcome resistance to its being stolen.

Except as otherwise provided by this endorsement, all terms and conditions, limitations and exclusions of this policy remain unchanged.
